Donation of Equipment

 - 2.3 that the Equipment will be of good construction or sound material, of adequate strength or free from defects in design, materials or workmanship; andfurther, LEEDS agree to the exclusion of all or any express or implied statutory or other warranties, terms, conditions or guarantees whatsoever, to the maximum extent permitted by law.
3. LEEDS agrees to undertake any work necessary to ensure that the Equipment complies with the requirements of the *Health and Safety at Work etc Act 1974*, *The Supply of Machinery (Safety) Regulations 2008* (as amended) and the *Provision and Use of Work Equipment Regulations 1998* (as amended) or other relevant legislation or regulations governing the use of the Equipment in a working environment before the machinery is taken into use or resold by the LEEDS. GSK excludes all liability which may result from the LEEDS's non compliance with such legislation or regulations.
4. To the best of our knowledge, any information made available, at our discretion, to LEEDS whether prepared by us or the original manufacturer, relating to the Equipment or its operation is provided "AS IS" and we do not represent or warrant to LEEDS that the information is accurate or that it will be useful or appropriate for your purposes.
